



## Jones County Solid Waste Commission Meeting Minutes

June 4th, 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Board of Supervisors), Jeff Swisher (Board of Supervisors), Will Roller (Morley), Wayne Peach (Monticello), Dave Goedken (Monticello), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Roller to approve the minutes from the previous month's meeting. Swisher seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Rohwedder making a motion to approve them. Peach seconded the motion and it passed with all voting ayes.

**A.** Presto presented the board with edited language defining break policy for the Employee Handbook. Rohwedder made a motion to approve it. Goedken seconded the motion and it passed with all ayes.

**B.** The board reviewed the proposed contract renewal with Liberty Tire. Rohwedder moved to approve the contract. Roller seconded the motion and it passed with all voting aye. Goedken made a motion to increase tire disposal fees from \$0.20/lb to \$0.25/lb effective July 1, 2024. Roller seconded the motion and it passed with all ayes.

**C.** The board reviewed the proposed White Goods contract renewal with Weikert Iron. Peach moved to approve the renewal. Goedken seconded and all voted aye.

**D.** The board reviewed the contract renewal with Linn Co. Solid Waste Agency for Household Hazardous Materials disposal and the changes in pricing. Goedken moved to approve the contract. Rohwedder seconded the motion and it passed with all ayes.

**E.** Taylor informed the board about Dean Husman's resignation from the Transfer Station and the status of advertising for a replacement.

**F.** Taylor updated the board on the status of a complaint to DNR about Leachate leaking from Pumping Station. Primary problems were addressed prior to DNR visit but we will receive a report with recommendations on improved containment to avoid future issues.

**G.** The board discussed pay raises for FY 2025 for the Transfer Station staff. Goedken moved that the full time employees receive a 4.75 percent increase effective July 1<sup>st</sup>. Roller seconded the motion and it passed with all ayes.

Peach moved to adjourn, and the meeting was adjourned at 5:40 p.m.
