The Jones County Solid Waste Commission meeting was held at the Jones County Courthouse. Those present were Chairman Russ Benke, Ned Rohwedder (Board of Supervisors), Jeff Swisher (Board of Supervisors), Will Roller (Morley), Wayne Peach (Monticello), Dave Dircks (Olin), and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Roller to approve the minutes from the previous month's meeting. Peach seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Rohwedder making a motion to approve them. Swisher seconded the motion and it passed with all voting ayes.
