WHERAS, the Jones County Board of Supervisors classified all American Rescue Plan Act funds as lost revenue on April 18, 2022 pursuant to the final rule on State and Local Fiscal Recovery Funds (SLFRF) issued by the U.S. Department of Treasury.

WHEREAS, based on the distribution guidelines from the US Department of Treasury, the following project has been approved for the use of said funds:

• Design, Engineering, and Construction of the Public Safety Storage Facility in the amount of \$1,600,000.00.

BE IT RESOLVED that the Jones County Board of Supervisors endorses the disbursement of American Rescue Plan Act Funds for the item listed and authorizes the Auditor to make these payments as they are presented. [2024-122]

> RESOLUTION FOR TRAFFIC SAFETY IMPROVEMENT PROGRAM Grant Application for CO RD E28 Road Segment Safety Improvements

WHEREAS, the Board of Supervisors, hereafter referred to as "the Board", believes the County Road E28 project, hereafter referred to as "the project" is in the best interest of Jones County, Iowa, and the residents thereof; and

WHEREAS, the State of Iowa has available Grant funds associated with the Traffic Safety Improvement Program up to a maximum of \$500,000 per location; and

WHEREAS, the County Engineer recommends application for funding of a Grade and Pave project that includes safety improvements on County Road E28 from County Road X28 to the Buffalo Creek Bridge.
