



Jones County Solid Waste Commission Meeting Minutes

September 10th 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Chairman Russ Benke, Jeff Swisher (Board of Supervisors), Will Roller (Morley), Dave Goedken (Monticello), Dave Dircks (Olin), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Roller to approve the minutes from the previous month's meeting. Goedken seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Swisher making a motion to approve them. Goedken seconded the motion and it passed with all voting ayes.

ECICOG

Alicia Presto updated the board on the conclusion of the Summer Reading Program as well as the completion of the SWAP Grant completion for the Glass Recycling Program.

Old Business:

- A. The board revisited what to do with the old scale house building. No decision was made about future use until after the building was cleaned out which is to occur before Jan 1st.
- B. The board reviewed the necessity to put out an RFP for leachate hauling but decided no action was required at this time.

New Business:

- A. The board reviewed the insurance policy renewal premiums and discussed whether to change deductibles to lower them. No changes were made.
- B. The board reviewed the changes in premiums for health insurance for 2025 which increased 3.35%. Goedken moved to renew with a second by Swisher. The motion passed with all ayes.
- C. Alicia updated the board on the resumption of safety training to be scheduled monthly .
- D. A check made out to Weikert Iron for \$822.00 had not been received until after 60 days had passed. They sent it back and asked for a new check to be issued. Swisher made a motion to approve voiding check #189878 and a new check issued. Goedken seconded the motion and it passed with all ayes.

Rohwedder moved to adjourn, and the meeting was adjourned at 6:00 p.m.
