



Jones County Solid Waste Commission Meeting Minutes

October 8th 2024

The Jones County Solid Waste Commission meeting was held at the Jones County Transfer Station. Those present were Chairman Russ Benke, Jeff Swisher (Board of Supervisors), Will Roller (Morley), Dave Goedken (Monticello), Dave Dircks (Olin), Wayne Peach (Monticello), Alicia Presto (ECICOG) and Karl Taylor (Director JCSWC).

The meeting was called to order at 5:00 p.m. by Chairman Benke.

A motion was made by Swisher to approve the minutes from the previous month's meeting. Goedken seconded the motion and it passed with all voting ayes.

The expenditures and financial reports were reviewed with Goedken making a motion to approve them. Roller seconded the motion and it passed with all voting ayes.
